**GENERAL STATEMENT OF RESPONSIBILITIES:**

The Receptionist will be part of the front office operations staff. The Receptionist will perform a variety of functions necessary to aid the efficient clinical office and billing operations for Lassen Indian Health Center. This position must be sensitive to the needs of the Indian community, its culture and traditions and all other clients we serve.

**SPECIFIC AREAS OF RESPONSIBILITIES:**

- Welcomes patients and visitors by greeting them professionally; in person or on the telephone, relaying or answering inquiries.
- Maximizes patient satisfaction, provider time and treatment room utilization by scheduling appointments appropriately in person or by telephone according to guidelines set by providers.
- Processes new patient packets by making sure they are complete and include copy of insurance and identification. Enters new patients into RPMS accurately and timely.
- Prepares for next business day by printing appointment list, calling patients to confirm appointments, running insurance at the beginning of the month and again two (2) days prior to their appointment.
- Assists in quality improvement efforts by assisting with GPRA related activities and work such as data entry.

- Initiates patient transportation requests for medical and dental appointments by inquiring whether transportation is needed and checking and booking transportation.
- Collects and processes co-pays and payments on accounts on the point system accurately. Is responsible for accurate tracking of deposits daily and turning those into fiscal. Keeps accurate records of deposits and stores them in appropriate place. Counts and is responsible for cash drawer daily.
- Maintains patient confidence and protects clinic operation by keeping information confidential following release of information protocols and other HIPAA (Health Insurance Portability and Accountability Act) requirements.
- Helps patients in distress by responding to emergencies and reports to medical or dental as appropriate.
- Contributes to team efforts by assisting other co-workers as needed to ensure streamlined efficient clinic and billing operations.
- Other duties as assigned.

**KNOWLEDGE, SKILLS AND ABILITIES:**

- A. Ability to work well under pressure.

- C. Strong interpersonal skills and the ability to work effectively with a wide range of individuals.

### **WORKPLACE ENVIRONMENT:**

1. Completed Susanville Indian Rancheria/Lassen Indian Health Center Application.
2. Copy of your High School Diploma AND College Degree or transcripts documenting your graduation or completion of your Degree.
3. Copy of your valid Driver's License.
4. Copy of any other certifications required.
5. Copy of Tribal Card, if claiming Indian Preference.
6. Copy of DD214 or other proof of Veteran status, if claiming Veteran's Preference.
