SUSANVILLE INDIAN RANCHERIA EXCLUSION ORDINANCE

ORDINANCE NO. 2019-001 **AMENDMENT #1**

PURPOSE: The Purpose of this Amendment is to keep the original Susanville Indian Rancheria Exclusion Ordinance No. 2019-001 except to allow the Susanville Indian Rancheria Tribal Business Council to immediately exclude nonmembers of the Susanville Indian Rancheria at the discretion of the Susanville Indian Rancheria Tribal Business Council. This amendment does not apply to any member of the Susanville Indian Rancheria.

6.0 Exclusion of nonmembers

6.1 The Tribal Business Council may exclude any nonmember (meaning not a member of the Susanville Indian Rancheria) for any grounds listed under section 3.1 of this ordinance or for any overriding public safety deemed appropriate by the Susanville Indian Rancheria Tribal Business Council

6.2 The Tribal Business Council must exclude the individual by resolution and by name and as much identifying information as possible in the resolution including the section of the Exclusion Ordinance violated and what the individual did to violate it. The exclusion becomes effective immediately and any member of Tribal Business Council or staff of the Susanville Indian Rancheria may take steps to enforce the exclusion order which is expressly limited to calling local police and/or authorities for the individual to either be escorted off the premises or charged with trespassing or whatever deemed proper by local authorities.

6.3 If the Susanville Indian Rancheria Tribal Business Council excludes an individual, then the Susanville Indian Rancheria must make all best efforts to forward a copy of the exclusion order to the individual. If no address can be found, then the Susanville Indian Rancheria may post in any local newspaper including any newspaper by the Susanville Indian Rancheria.


6.4 Any person who is excluded is allowed to appeal their exclusion by mail to the Susanville Indian Rancheria Tribal Business Council by writing an appeal letter denying the allegations to the Tribal Chairman or Tribal Administrator who will forward to the Tribal Business Council. Any person excluded will have 15 days if mailed to the individual and 60 days if posted on a public newspaper (including Susanville Indian Rancheria newsletters). If an appeal is received, the Tribal Business Council must meet at their convenience to discuss the appeal and may either 1.) Deny the appeal or 2.) Accept the appeal and/or either request the individual come in to

explain the situation and present evidence proving their innocence. If the Tribal Business Council finds the exclusion is unwarranted, the Tribal Business Council may nullify the exclusion of that individual. Tribal Business Council can set any and all timelines after an appeal is received.


CERTIFICATION
